Suite Solutions Scholarship Program Fact Sheet

Program Overview

In response to the overwhelming number of consumer bankruptcies in Southern California, Suite Solutions will be donating \$30,000 in education grants to local students whose families have recently filed for consumer bankruptcy in California. Eighteen finalists will be selected by a qualified panel of judges based on the established criteria. The top three finalists will receive scholarships of \$5,000 and the remaining 15 finalists will be awarded \$1,000. All applicants must be nominated by a partnering attorney.

Candidate Eligibility

To qualify for the Suite Solutions Scholarship Program, candidates must be:

- nominated by a consumer bankruptcy attorney who was invited to participate by Suite Solutions.
- a child whose parent(s) have filed for consumer bankruptcy in California.
- a Southern California resident.
- a high school senior graduating in the spring of 2009 or current undergraduate college student enrolled for the upcoming fall semester at a two-year or four-year accredited college.
- a student who demonstrates participation in his/her school or community through academic achievement, participation in extracurricular activities and/or community service.

Application Guidelines

Applicants must submit:

- a completed copy of the official 2009 Suite Solutions Scholarship Program application (available at www.suitesolutions.info/scholarship.asp).
- a 400 word essay typed in 12 pt., Times New Roman font as outlined on the application form.
- proof of enrollment for the 2009 fall semester such as a letter of enrollment from the school registrar's office or copy of Fall registration/class schedule.
- the most recent copy of his/her school transcripts.

The application and required materials must be postmarked no later than **August 10, 2009** and sent to:

Judging Procedure

Applicants will be judged on (1) the completeness of the application, (2) the quality of the essay, (3) the student's achievements and (4) appropriate family need. All applications will be evaluated according to a point system.

15 finalists will be selected to win \$1,000 scholarships; 3 finalists will be selected to win \$5,000 scholarships. Scholarship winners and their nominating attorneys will be notified in August 2009.
